

Cookie Policy

Introduction

The European Union approved a major reform of the data protection framework, by adopting the 'General Data Protection Regulation' (GDPR or Regulation), which is directly applicable in Member States. The Regulation replaced Directive 95/46/EC ('Data Protection Directive') and its application became mandatory as of 25 May 2018, two years after its entry into force. The Regulation strengthened the right to personal Data Protection, and recognized it as a fundamental right in the EU. The Regulation was also a necessary and urgent response to the challenges posed by technological developments that allow the collection and processing of large amounts of personal data in real time, enabling automated decisions beyond human intervention. The Regulation meets the need for privacy protection, a matter increasingly felt by European citizens.

The Companies, listed in the table available at this link [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#), consider protection of the personal data of their customers, employees and suppliers an obligation that goes beyond mere regulatory compliance.

For this reason, they have their own Data Protection Framework, understood as the set of roles and responsibilities, internal rules and methodologies, aimed at ensuring the management and mitigation of risks to the rights and freedoms of individuals linked to the processing of personal data.

Rights of Data Subjects

EU Regulation 2016/679 (Articles 15 to 23) grants data subjects the exercise of specific rights. In particular, in relation to the processing of your personal data, you have the right to request, from the companies listed in the table available at this link [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#), access to your data; modification, cancellation and portability of your data; restriction of processing; objection to processing.

More specifically:

- Right of access: You may ask the companies listed in the table available at this link [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#), to confirm whether or not personal data concerning you are being processed and, if so, to obtain access to your personal data (art.15);
- Right to rectification: You may obtain from the companies listed in the table available at this link [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#), the rectification of inaccurate personal data concerning you (art.16);
- Right to cancellation /right to be forgotten: Under certain circumstances, you may obtain from the companies listed in the table available at this link [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#), the deletion of personal data concerning you (art.17);
- Right to limitation of processing: Under certain circumstances, you may obtain limitation of data processing from the companies listed in the table available at this link [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#) (art.18);
- Right to data portability: Under certain circumstance, you may obtain from the companies listed in the table available at this link [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#), portability of your personal data in a structured, commonly used and machine-readable format. Also, you have the right to transfer them to another Data Controller without hindrance from the companies listed in the table available at this link [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#) (art.20);
- Right to opposition to processing: You may object at any time, on grounds relating to your particular situation, to the processing of personal data concerning you; the companies listed in the table available at this link [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#) shall refrain from further processing your personal data, unless they prove the existence of compelling legitimate grounds for processing which override your interests, rights and freedoms, or in the event of establishment, exercise or defence of a legal claim (art.21).

At any time, you may ask to exercise your **rights** to the Data Controller company, by reaching out to it at their e-mail address, available at this [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#), or by contacting the **Data Protection Officer/ Data Protection Referent** at the email address available at this [\[Supplier station del Gruppo FS \(bravosolution.com\)\]](#).

In addition, you may lodge a complaint with the Supervisory Authority, which in Italy is the Garante per la Protezione dei Dati Personali.

Processing of Personal Data of users visiting the website www.acquistionline.gruppofs.it

This Information Notice describes the personal data that the companies listed in the table available at this link [[Supplier station del Gruppo FS \(bravosolution.com\)](http://Supplier station del Gruppo FS (bravosolution.com))] collect from users, and how they are processed. The Information Notice concern processing of the personal data of users visiting the www.acquistionline.gruppofs.it, for the purposes specifically identified below, and does not concern any data collected through other methods, sources or any other websites that may be reached by the user through links present on this website, unless expressly specified.

Company information is listed in the table available at this [[Supplier station del Gruppo FS \(bravosolution.com\)](http://Supplier station del Gruppo FS (bravosolution.com))].

With reference to the processing of data of users visiting the website www.acquistionline.gruppofs.it, pursuant to Article 13 of EU Regulation 2016/679, each Company informs that:

1. Personal data provided voluntarily (e.g. first name, last name, e-mail address,) will be processed solely for the purposes described in the specific 'Data Protection Notice' drafted by the Data Controller. These Information Notices, which can be consulted when providing the data, will include further information, such as the legal bases of the processing, the possible recipients of the personal data, the period of retention of the personal data (or the criterion for determining this period), the existence of automated decision-making processes, including profiling, as well as all information useful for exercising privacy rights;
2. No personal data other than those indicated in this Information Notice will be used by the Data Controller, and they will be immediately and irreversibly deleted from our systems;
3. Data will not be used for any other purpose, except with the explicit consent of the Data Subject;
4. When browsing the website, technical information relating to the hardware and software used by visitors is collected (e.g. IP addresses or domain names of the computers and terminals used by users, URI/URL notation addresses, etc.). This information does not reveal the user's personal data, but only data of a technical/informative nature used in an aggregate and anonymous manner for the sole purpose of improving the quality of the service and providing diagnostic information in the event of technical problems, and/or possibly statistics concerning the use of the site;
5. Cookies: A cookie is a small file in which certain information concerning user navigation habits is stored; it is sent by websites to the terminals (computers, tablets, etc.) of users accessing them. Some cookies are automatically deleted at the end of the browsing session, while others remain stored in the terminal, normally hosted in the browser used (e.g. Internet Explorer, Mozilla Firefox, Google Chrome, etc.).

This website only uses cookies strictly necessary for the proper functioning of the site and provision of the online service. Such cookies are temporary, lose their meaning when the session is closed and are in any case deleted from the computer once the browser is closed.
